To register and pay with a credit card/debit card for a panel online

- In the “Search” bar, enter your City and State.
- Click on a location.
- Choose a Start Date and click on “Register”.

MADD IMPACT PANELS FOR MINNESOTA

- To register and pay with a credit/debit card for a panel online, click the county of the panel you'd like to attend. Then, find the "Click here to Register Online" link. Note: Not all panel locations allow for online registration and payment. The only acceptable form of payment at these locations is by MONEY ORDER.
- You can register without a credit/debit card via the phone number associated with each panel. The only acceptable payment at the door is MONEY ORDER. Cash/checks/credit cards will not be accepted at the actual panel locations. Pre-registration and payment is highly recommended.
- Unless Court ordered to attend a panel, anyone under the age of 18 will NOT be allowed into a panel. If you are Court ordered and are under the age of 18, you must be accompanied by a parent or legal guardian.
- Confirmation of online registration will be given via email to the email address provided. If you do not receive email verification of payment, you will need to follow up with the MADD MN office (651-523-0802) to verify your payment was received. You may leave a message with your name, desired panel location, date of registration and phone number, and someone will get back to you once verification of payment has been made.
- Panel Fee: \$50.00 (Money Order or pre-pay with credit/debit card online). There is a \$3.00 processing fee assessed when registering online.
- MADD does NOT accept checks or credit cards at the actual panel – money orders only. Pre-registration and payment is highly recommended.
- If you have not prepaid, payment will be collected at the panel. MADD MN does not waive fees.
- If you are suspected of using alcohol or drugs, law enforcement will be called. NO REFUNDS will be given if you are asked to leave because of suspicion of drug or alcohol use.
- If you choose to or are asked to leave at any time during the presentation, you will not be re-admitted and you will not be refunded your \$50.00 fee. If you are asked to leave the panel for any reason, you will not receive verification of attendance and a refund will not be issued.
- If you register and pay online, but are no longer able to attend the panel you chose, you will need to contact the MADD MN office a minimum of 24 hours prior to the panel to reschedule for another panel and transfer your registration fee. In certain emergency situations, MADD MN may agree to transfer your registration to another panel if you are unable to call prior to the panel date. In these situations, you must call the MADD MN office within 24 hours after the panel in order to be eligible for an emergency exemption to this policy.
