Conditions of Probation

There are standard rules required of everyone placed on probation, such as regular reporting to your agent and remaining law abiding. The Court may modify those rules and impose additional conditions appropriate to the individual, e.g., jail time, restitution, chemical dependency treatment, other counseling, or no contact with victims.

You may be required to report to a probation officer on a regular basis – ranging from multiple contacts per week to non-reporting probation. The level and type of supervision depends on many factors. The probation officer after reviewing these factors will determine the place and time of these contacts.

Any violation of the rules or conditions of probation or any arrest could result in you being placed in custody pending further action of the Court, which may include revocation of your probation or execution of your sentence.

Leaving the State

Travel:

Many probationers are restricted from out of state travel without permission of your supervising probation officer. If you are uncertain this restriction applies to you, ask your agent for clarification. Requests for travel outside of Minnesota requires approval, verification and must be made in a time frame as specified by your agent.

Moving:

To move permanently to another state requires transfer of supervision to an agent in the other state and permission of the receiving state. You may not re-locate to a new state without first receiving the permission of that state.

Voting & Holding Public Office

A person convicted of a felony loses the right to vote or hold public office until discharged from probation by order of the Court or upon expiration of sentence/probation period. Following discharge or expiration from all felony offenses, your civil rights—including the right to vote in this state and the right to be elected to public office—are restored.

Employment

If you have a criminal conviction, you may be restricted from certain jobs, such as school bus driver, teacher, or health care worker.

Possession of Firearms

While on probation for any felony offense, you cannot possess or use any firearm. State and federal laws also prohibit the possession or use of firearms by other offenders who are convicted of certain misdemeanor offenses.

If convicted of a *crime of violence* as defined by Minnesota law, you are not entitled to ship, transport, possess or receive a firearm for the remainder of your lifetime. If convicted of a felony not classified as a *crime of violence*, these rights are restored after discharge from supervision. A *crime of violence* includes controlled substance crimes and other offenses that may not seem violent in nature.

The rules regarding possession of a firearm are complex and may require legal counsel for your particular case.

Predatory Offender Registration

If you are ordered by the Court or if you were convicted of a past predatory offense requiring registration, you may be required to register as a predatory offender. (Predatory offenses are usually sexual in nature.) You must notify your agent of the requirement to update the BCA registry when changes to the following areas exist:

- Changes to address, including alternative locations which you stay.
- Changes to vehicles that are registered to you or that you operate.
- Changes to your employment or school.
- Changes to your appearance.
- Incarceration status or changes to criminal history.

Correctional Service Fees

Correctional service fees will be assessed according to the following 2020 fee schedule. This fee applies only one time for each file.

Other Corrections Department services and programs may include additional fees.
